AMENDED EMERGENCY ORDER REGARDING PROBATE DIVISION

NATURE OF PROCEEDINGS: AMENDED ORDER

In furtherance of compliance with the California Department of Public Health and CDC guidelines and recommendations, the Probate Division of the Superior Court of California, County of Shasta is taking the following precautionary measures to ensure the health and safety of the community. Until further notice, this order pertains to all probate matters pending in Department 7 and all guardianship calendars pending in Department 12.

- 1. The Court will continue to hear the regular Monday Probate Calendar in Department 7 at 2:30 p.m. only through **Monday, March 23, 2020**.
- 2. All matters on the Monday Probate Calendar in Department 7 at 2:30 and all matters on the Monday Guardianship Calendar in Department 12 will be continued to future dates as follows:

If Notice of Hearing was required for the current hearing date, a Notice of Hearing will be required to be timely served for the continued hearing date. If proof of publication was required for the current hearing date, timely proof of publication will be required for the continued hearing date.

3. After Monday, March 23, 2020, and until further notice, the Probate Division, including guardianship matters heard in Department 12, will only hear emergency matters. These matters would include, for example, emergency applications for appointment of a temporary conservator, special administrator, or temporary guardian, or any other applications of an emergent nature. The court may make special orders pertaining to the date, time, locations, and conditions under which those matters are heard, so as to comply with applicable Public Health directives. While the clerk's office is closed, papers can be deposited in the drop box just inside the entrance to the Courthouse on the first floor.

- 4. All Letters of Temporary Guardianship and Temporary Conservatorship that are set to expire prior to May 4, 2020, are hereby extended an additional 60 days past the current expiration date. The clerk's office can issue updated letters where necessary.
- 5. Attorneys, Parties and members of the public will continue to receive current information concerning Emergency Orders of the Shasta County Superior Court on the Court's website, www.shasta.courts.ca.gov. More specific information pertaining to the Probate Division will also be posted on the tentative ruling page for the Probate Department. Specific information regarding Guardianships will be listed under Dept. 12.
